

PROPOSED AMENDMENTS TO THE NCIA ARBITRATION RULES 2015 (REVISED 2019)

1. Introduction of the Role of a Tribunal Secretary in the Rules.

Definition of the term:

"Tribunal Secretary" means any person approved by the Parties, at the request of the Arbitral Tribunal, to render the services prescribed under clause 3 of the NCIA Arbitral Tribunal Secretary Guidelines, 2023 and its amendments from time to time.

Rule 14A Tribunal Secretary

- (1) An Arbitral Tribunal may obtain assistance from a Tribunal Secretary in relation to an arbitration in accordance with the NCIA Arbitral Tribunal Secretary Guidelines, 2023 and its amendments from time to time.
- (2) The Tribunal Secretary's fee shall be calculated in accordance with Part 6 of the First Schedule.
- (3) The Tribunal Secretary shall agree in writing upon fee rates conforming to the provisions of Part 6 of the First Schedule.
 - (4) The Parties shall be jointly and severally liable for payment of the Tribunal Secretary's fees and expenses.
- 2. Introduction of the following sub-rule (4) under the General provisions in Part 1 of the First Schedule on Fees and Costs:

"Any transfer or currency exchange charges shall be borne by the Party paying the fees and expenses."

3. Introduction of the following sub-rule under Fees and Costs in Part 2 of the First Schedule:

"Where a tribunal secretary is appointed, the Arbitral Tribunal's fees shall include the amount billed for the tribunal secretary fees."



4. Proposal to increase the appointment fee from Kshs 5,000 to Kshs 10,000 under Rule 7, Requests to act as appointing authority. Thus, the provision to read as follows:

"Any party intending to nominate the Centre to act as appointing authority shall make the request to the Registrar together with payment of a non-refundable appointment fee of USD 1000 in international arbitration and KES 10,000 in domestic arbitration payable to the Centre."

5. Introduction of a Fixed Rate – Fast Tracked Documents Only Arbitration for International Arbitrations as follows:

6. Introduction of the following statement in the First Schedule under Part 3:B on Administrative Costs to provide for the Centre's administrative costs when a Tribunal Secretary is appointed.

*Where a Tribunal Secretary is appointed, the administrative costs shall include an additional 10% of the fees above.



7. Introduction of a Fixed Rate table to provide for Arbitrator's Fees in a Fast Track Documents Only Arbitration (Domestic Arbitration) under Part 4 of the First Schedule:

- 8. Proposal to increase the rate charged as administrative costs from 1.5% to 20% in Part 4 of the First Schedule thus the provision to read as follows:
 - **B.** Administrative Costs

20% of the rate charged for Arbitral Tribunal's fees.

- 9. Proposal to increase the Administrative Costs in a Domestic Emergency Arbitration from Kshs 10,000 to Kshs 50,000 in Part 5 of the Schedule.
- 10. Introduction of the Tribunal Secretary's Fees in Part 6 of the First Schedule as follows:

Tribunal Secretary's Fees for Domestic Arbitrations

An hourly rate of between Kshs 3,000 to Kshs 8,000 to be agreed by the Parties at the time of appointment.
